## **REQUEST FOR A QUOTATION: FOR EXISTING MTC WEBSITE MAINTENANCE & FULL SUPPORT**

### **Summary**

The City of Johannesburg (hereafter referred to as either the City or COJ) made a strategic decision to invest in the development of a Johannesburg Broadband Network (JBN) to cater to its internal telecommunications requirements at a reduced cost as well as to stimulate social and economic development in Johannesburg. After a series of previous agreements, the City transferred the JBN to a Municipal Entity (ME) named Metropolitan Trading Company (Pty) Ltd (also referred to as MTC) which aims to create better lives for the citizens of Johannesburg and realise the vision and the objectives of the City. MTC began operating as such on the 4th of September 2015.

MTC is a Broadband Network Company designed to offer both wholesale data services to public and private entities as well as retail services and provide incidental services on behalf of the City. MTC mandate: MTC shall offer Wholesale services to the market and Internal Retail services. Spare capacity on the network will be provided to Network Operators and to ICT Resellers who will then sell directly to Enterprises, SMEs, and households. In addition, the Company shall perform any other municipal services assigned to it by COJ as defined in the Service Delivery Agreement (SDA) entered between MTC and COJ, as amended from time to time.

MTC is responsible for the enablement of the many Smart City Programmes of the City as well as rendering the full spectrum of ICT, networking services, and other incidental services to the city and many of its MEs.

### **Background**

MTC requires the services of a capable web development company for maintenance and full support of an existing MTC website.

The website is currently hosted by an existing service provider and the contract with the service provider is coming to an end.

### **Scope of work**

Taking over services and maintenance of the MTC's website in a secure and trusted hosting environment and secured.

### **Requirements**

The Service Provider is expected to oversee the process of urgently taking over the maintenance and full support from the
